



Chairman's Statement

主席報告

After the announcement of the 2015 Paris Climate Conference, energy saving products and services market has been one of the focus industries. Synergy Group, being an early entrant in provision of energy saving solutions, is well-positioned to further enhance both our local and global presence.

On behalf of the board of Directors (the "Board") of Synergy Group Holdings International Limited (the "Company"), I am pleased to report to our valued shareholders and investors the results of the Company and its subsidiaries (collectively referred to as the "Group") for the financial year ended 31 March 2016.

After the announcement of the 2015 Paris Climate Conference, there has been an increase in the awareness of environmental protection and demand for energy saving products, especially in some Asian developing countries. Recently, energy saving products and services market has been one of the focus industries, mainly because of the growing concern of the public on environmental protection due to severer climate change and higher operating costs suffered by most corporations due to the expected increasing electricity prices.

We are one of the leading energy management contract providers for lighting projects in Hong Kong, with full range capabilities on providing a broad range of energy saving services for lighting solutions, product customisation, on-site inspection and measurement, project deployment and after-sales services.

二零一五年巴黎氣候會議公佈後,環保意識有所加強,而對節能產品的需求亦有所上升,尤其是於若干亞洲的發展中國家。近期,節能產品及服務市場成為其中一個重點行業,此乃主要由於氣候變化加劇令環境保護問題日益備受公眾關注,及大部份企業因預期電費上升而面對更高的營運成本所致。

我們為香港領先的照明項目能源管理合約供應商之一,於照明解決方案、產品訂造、實地檢查及量度、項目部署以及售後服務方面,擁有全面提供廣泛節能服務的能力。



For the year ended 31 March 2016, the Group recorded a total revenue of HK\$130.1 million, representing an increase of 16.7% as compared to HK\$111.5 million for the year ended 31 March 2015. For the year ended 31 March 2016, profit attributable to the owners of the Company amounted to HK\$35.4 million, representing an increase of 35.0% as compared to the corresponding amount of HK\$26.2 million for the year ended 31 March 2015.

For the year ended 31 March 2016, the Group has been successful in expanding its leasing business; and it has also expanded its leasing business into the Indonesian market. As a result, revenue generated from our leasing service segment increased by 142.1% from HK\$8.8 million for the year ended 31 March 2015 to HK\$21.4 million for the year ended 31 March 2016, while both of our trading segment and consultancy service segment had a steady growth.

Benefiting from the increasing awareness of energy saving products and services globally, the Group, being an early entrant in provision of energy saving solutions, is well-positioned to further enhance both our local and global presence.

截至二零一六年三月三十一日止年度,本集團成功擴充其租賃業務,亦將其租賃業務擴充至印尼市場。因此,我們的租賃服務分部產生的收入由截至二零一五年三月三十一日止年度的8.8百萬港元增加142.1%至截至二零一六年三月三十一日止年度的21.4百萬港元,而我們的貿易分部及諮詢服務分部均穩定增長。

本集團作為提供節能解決方案的早期市場參 與者,受惠於全球對節能產品及服務之日益 關注,在進一步發展本地及全球業務方面佔 有優勢。

Management Discussion and Analysis

管理層討論及分析

Business Review

For the year ended 31 March 2016, we had a record of success in our leasing service segment. This was attributable to the effort we put forth in expanding into the overseas market, in view of the increase in the awareness of environmental protection and growing demand for energy saving products in developing countries in order to meet the emission reduction targets.

Revenue generated from our leasing service segment increased by 142.1% from HK\$8.8 million for the year ended 31 March 2015 to HK\$21.4 million for the year ended 31 March 2016 due to the energy management contracts under lease arrangement that were entered during the current year were of larger contract amounts and of contributions from businesses generated from overseas markets. Revenue generated from our trading segment increased by 5.4% from HK\$74.9 million for the year ended 31 March 2015 to HK\$78.9 million for the year ended 31 March 2016 due to the increase in sales of LED products, while revenue generated from our Consultancy Services (as herein after defined) segment for the year ended 31 March 2016 increased by 7.1% to HK\$29.8 million from HK\$27.8 million for the year ended 31 March 2015 due to the increase in resources we placed in such segment such as additional staff employed.

Details of segment information are set out in Note 6 to the consolidated financial statements.

業務回顧

截至二零一六年三月三十一日止年度,我們的租賃服務分部取得成功。此乃歸因於我們鑒於發展中國家為達到減排目標,環保意識不斷增強及對節能產品的需求不斷增加,致力擴充海外市場所致。

自我們的租賃服務分部產生的收入由截至二 零一五年三月三十一日止年度的8.8百萬港元 增加142.1%至截至二零一六年三月三十一日 止年度的21.4百萬港元,乃由於本年度訂立 合約金額較大的租賃安排下的能源管理合約 及海外市場業務作出的貢獻所致。自我們的 貿易分部產生的收入由截至二零一五年三月 三十一日止年度的74.9百萬港元增加5.4%至 截至二零一六年三月三十一日止年度的78.9 百萬港元,乃由於LED產品銷售增加所致,而 自我們的諮詢服務(定義見下文)分部產生的 收入則由截至二零一五年三月三十一日止年 度的27.8百萬港元增加7.1%至截至二零一六 年三月三十一日止年度的29.8百萬港元,乃 由於我們投放更多資源於有關分部,例如聘 請額外員工所致。

Principal Risks and Uncertainties

- Our consultancy services (the "Consultancy Services"), which are provided by the Group to third parties in assisting them in providing energy saving services in their markets, provided to our customers were project-based and demand for our Consultancy Services may fluctuate.
- We rely on our sub-contractors for providing services of deployment and installation of lighting products to customers.
- We rely on our key management to conduct the Group's business and the inability to retain or attract senior management personnel will adversely affect our performance.
- There may be changes in consumer preferences and habits in green technologies.

Financial Review

Total revenue was HK\$130.1 million for the year ended 31 March 2016, representing a 16.7% increase as compared to that for the year ended 31 March 2015. There has been an increasing demand for the Group's energy saving products and services. Gross profit margin decreased from 57.3% for the year ended 31 March 2015 to 53.2% for the year ended 31 March 2016. Such decrease was mainly due to an increase in revenue generated from the leasing service segment of which the leasing services in our newly developed overseas market had a relatively lower gross profit margin than other markets.

Other income and gains, which mainly consisted of a monthly service fee of HK\$150,000 received from an associate of our Group, increased from HK\$1.9 million for the year ended 31 March 2015 to HK\$2.2 million for the year ended 31 March 2016 mainly due to the reversal of warranty provision upon expiry.

Selling and Distribution Costs

The Group's selling and distribution costs for the year ended 31 March 2016 were HK\$4.6 million, representing an increase of 66.2% from HK\$2.8 million for the year ended 31 March 2015. The increase was mainly due to the increase in salaries and the increase in marketing activities such as participation in Eco Expo Asia 2015 and sponsoring a luncheon in relation to sustainable energy future that was held by World Green Organisation.

主要風險及不確定性

- 一本集團向第三方提供諮詢服務(「諮詢服務」)以協助彼等於其市場上提供節能服務,該服務乃以項目為基準提供予我們的客戶,且對我們諮詢服務的需求或會波動。
- 我們倚賴我們的子分包商為客戶提供部署及安裝照明產品的服務。
- 我們倚賴我們的主要管理層進行本集團的業務,而未能挽留或吸引高級管理層 人員將對我們的表現造成不利影響。
- 客戶對綠色科技的偏好及喜好可能有變。

財務回顧

截至二零一六年三月三十一日止年度的總收入為130.1百萬港元,較截至二零一五年三月三十一日止年度增加16.7%。市場對本集團的節能產品及服務的需求日益增加。毛利率由截至二零一五年三月三十一日止年度的57.3%下跌至截至二零一六年三月三十一日止年度的53.2%。該跌幅主要由於租賃服務分部所產生的收入增加,而當中我們新發展的海外市場的租賃服務毛利率相對低於其他市場所致。

主要包括收取來自本集團聯營公司的每月服務費150,000港元的其他收入及收益由截至二零一五年三月三十一日止年度的1.9百萬港元增加至截至二零一六年三月三十一日止年度的2.2百萬港元,主要由於保修撥備於到期後撥回所致。

銷售及分銷成本

截至二零一六年三月三十一日止年度,本集團的銷售及分銷成本為4.6百萬港元,較截至二零一五年三月三十一日止年度的2.8百萬港元增加66.2%。該增加主要由於薪金上升及舉辦更多營銷活動所致,例如參與二零一五年國際環保博覽及贊助由世界綠色組織舉辦有關可持續能源未來的午宴。

Administrative Expenses

The Group's administrative expenses for the year ended 31 March 2016 were HK\$15.6 million, representing a decrease of 29.8% from HK\$22.2 million for the year ended 31 March 2015. The decrease was mainly due to the net effect of the decrease in listing related professional expenses and the increase in salaries (including directors' remuneration) and overseas travelling expenses as a result of the expansion of our Group's business.

Finance Costs

The Group's finance costs increased from approximately HK\$13,000 for the year ended 31 March 2015 to approximately HK\$421,000 for the year ended 31 March 2016. The increase was due to the interest expenses arising from the new bank borrowings drawn down of HK\$25.3 million during the year.

Other Expenses

The Group's other expenses increased to HK\$1.5 million for the year ended 31 March 2016 from HK\$1.1 million for the year ended 31 March 2015. Such expenses were mainly derived from the disposal of property, plant and equipment during the year.

Income Tax Expense

The Group's income tax expense for the year ended 31 March 2016 was HK\$9.2 million, representing a decrease of 6.3% from HK\$9.8 million for the year ended 31 March 2015. The decrease was mainly due to the decrease in deferred tax.

Profit for the Year

As a result of the foregoing, our profit attributable to the owners of the Company increased by 35.0% from HK\$26.2 million for the year ended 31 March 2015 to HK\$35.4 million for the year ended 31 March 2016. Excluding the non-recurring listing-related expenses, our profit for the year ended 31 March 2016 recorded as HK\$35.4 million, representing a 15.4% decrease as compared to HK\$41.9 million for the year ended 31 March 2015.

行政開支

截至二零一六年三月三十一日止年度,本集團的行政開支為15.6百萬港元,較截至二零一五年三月三十一日止年度的22.2百萬港元減少29.8%。該減少主要由於與上市有關的專業費用減少以及薪金(包括董事酬金)增加及因本集團業務擴展而令海外差旅開支增加的淨影響所致。

融資成本

本集團的融資成本由截至二零一五年三月三十一日止年度的約13,000港元增加至截至二零一六年三月三十一日止年度的約421,000港元。該增加主要由於年內提取新銀行借款25.3百萬港元產生的利息開支所致。

其他開支

本集團的其他開支由截至二零一五年三月三十一日止年度的1.1百萬港元增加至截至二零一六年三月三十一日止年度的1.5百萬港元。該等開支主要來自年內出售物業,廠房及設備。

所得税開支

截至二零一六年三月三十一日止年度,本集團的所得税開支為9.2百萬港元,較截至二零一五年三月三十一日止年度的9.8百萬港元下跌6.3%。跌幅乃主要由於遞延税項減少所致。

年內溢利

鑒於前述,本公司擁有人應佔溢利由截至二零一五年三月三十一日止年度的26.2百萬港元上升35.0%至截至二零一六年三月三十一日止年度的35.4百萬港元。撇除非經常性上市相關費用,截至二零一六年三月三十一日止年度錄得35.4百萬港元的溢利,較截至二零一五年三月三十一日止年度的41.9百萬港元下跌15.4%。

Liquidity and Financial Resources

The shares of the Company were listed on GEM on 24 March 2015 (the "Listing").

The Group mainly finances its business with internally generated cash flows, bank borrowings and proceeds from the Listing. As at 31 March 2016, currents assets of the Group amounted to HK\$148.4 million, representing an increase of 46.0% from HK\$101.7 million as at 31 March 2015. Current assets mainly comprised cash and bank balances (including pledged bank deposits) of HK\$29.1 million (2015: HK\$27.7 million) and trade receivables of HK\$84.9 million (2015: HK\$58.6 million).

As at 31 March 2016, the Group's current liabilities mainly comprised borrowings of HK\$25.3 million (2015: HK\$0.1 million), trade payables of HK\$16.3 million (2015: HK\$6.4 million) and accruals, other payables and deposits received of HK\$7.3 million (2015: HK\$6.8 million).

流動資金及財務資源

於二零一六年三月三十一日,本集團的流動負債主要由借款25.3百萬港元(二零一五年:0.1百萬港元)、貿易應付賬款16.3百萬港元(二零一五年:6.4百萬港元)以及應計費用、其他應付款項及已收按金7.3百萬港元(二零一五年:6.8百萬港元)組成。

Management Discussion and Analysis

管理層討論及分析

The Group's current ratio decreased from 4.9 times as at 31 March 2015 to 2.6 times as at 31 March 2016. The Group has sufficient working capital to meet the current liquidity demand within at least 12 months from the date of this report.

The total outstanding borrowings of the Group as at 31 March 2016 was HK\$25.5 million (31 March 2015: approximately HK\$449,000) due to banks and an independent third party. The increase was due to the new bank borrowings of HK\$25.3 million that was drawn during the year.

As at 31 March 2016, the Group's equity attributable to the owners of the Company was HK\$132.2 million, representing an increase of 36.5% from HK\$96.9 million as at 31 March 2015.

As at 31 March 2016, a time deposit of HK\$2.5 million was pledged as a security for the bank facilities (31 March 2015: Nil). Save as disclosed above, the Group has no other charges on its assets as at 31 March 2016.

Contingent Liabilities

The Group had no significant contingent liabilities as at 31 March 2016.

Associated Company

Synergy Cooling Management Limited ("SCML", together with its subsidiaries, the "Cooling Group") is an associated company of the Group which was owned as to approximately 27.17% (subsequently increased to approximately 36.59% and details are set out in the paragraph below) by the Group. SCML wholly owns Synergy Cooling Management (H.K.) Limited ("SCML (HK)") and indirectly wholly owns Synergy ESCO (Malaysia) Sdn. Bhd. ("SE (Malay)"). Both SCML (HK) and SE (Malay) are principally engaged in the business of energy saving management.

本集團的流動比率由二零一五年三月三十一日的4.9倍下降至二零一六年三月三十一日的2.6倍。本集團擁有充足的營運資金以應付其目前於本報告日期起計最少12個月內的流動資金需求。

本集團於二零一六年三月三十一日的未償還予銀行及一名獨立第三方的借款總額為25.5百萬港元(二零一五年三月三十一日:約449,000港元)。該增加乃由於年內提取的新銀行借款25.3百萬港元所致。

於二零一六年三月三十一日,本集團的本公司擁有人應佔權益為132.2百萬港元,較於二零一五年三月三十一日的96.9百萬港元增加36.5%。

於二零一六年三月三十一日,一筆定期存款 2.5百萬港元已抵押為銀行融資的保證金(二 零一五年三月三十一日:無)。除上文披露者 外,於二零一六年三月三十一日,本集團概 無就其資產作出任何其他押記。

聯營公司

Synergy Cooling Management Limited (「SCML」,連同其附屬公司統稱「空調集團」)為一間本集團的聯營公司,本集團擁有其約27.17%權益(其後增加至約36.59%,詳情載於以下段落)。SCML全資擁有滙能空調管理(香港)有限公司(「SCML (HK)」)及間接全資擁有Synergy ESCO (Malaysia) Sdn. Bhd.(「SE (Malay)」)。SCML (HK)及SE (Malay)均主要從事節能管理業務。

On 6 October 2015 (after trading hours), Synergy Group Worldwide Limited ("Synergy Worldwide") as a purchaser entered into the sale and purchase agreement with Fuqi Holdings Limited as a vendor pursuant to which Fuqi Holdings Limited agreed to sell, and Synergy Worldwide agreed to acquire, approximately 9.42% interest in SCML at a consideration of HK\$19.5 million. The acquisition was completed on 8 October 2015 and upon completion, Synergy Worldwide has become interested in approximately 36.59% in SCML. Details of the acquisition are set out in the announcements of the Company dated 6 October 2015 and 14 October 2015.

The turnover of the Cooling Group for the year ended 31 March 2016 was HK\$9.6 million, representing an increase of 58.7% from HK\$6.1 million for the year ended 31 March 2015. It was mainly attributable to the incorporation of SE (Malay) during the year ended 31 March 2015 in accordance with Cooling Group's expansion strategy. The net loss attributable to the shareholders of the Cooling Group for the year ended 31 March 2016 was HK\$13.3 million which remained stable as compared to HK\$13.3 million for the year ended 31 March 2015.

During the year, the Group made advances of HK\$5.2 million to the Cooling Group at interest rate of 5% per annum.

Save as disclosed above, there were no other significant investments held, material acquisition or disposal of subsidiaries and affiliated companies, and other plans for material investments or capital assets during the year ended 31 March 2016.

Guarantees

During the year, a Hong Kong subsidiary of the Group has committed to provide corporate guarantees to two independent third parties in Malaysia in respect of equipment lease agreements entered into between the independent third parties and an associate of the Group. The duration of the agreements were ranging from 48 months to 59 months, with average monthly rent charged to the associate of approximately RM23,000 each (equivalent to approximately HK\$46,000 each).

Save as disclosed above, we did not have any material guarantees as at 31 March 2016.

空調集團的營業額由截至二零一五年三月三十一日止年度的6.1百萬港元增加58.7%至截至二零一六年三月三十一日止年度的9.6百萬港元。此乃主要歸因於SE (Malay)於截至二零一五年三月三十一日止年度根據空調集團的擴展策略而註冊成立所致。截至二零一六年三月三十一日止年度,空調集團股東應佔淨虧損為13.3百萬港元,與截至二零一五年三月三十一日止年度的13.3百萬港元相比維持穩定。

年內,本集團按年利率5%向空調集團墊款5.2 百萬港元。

除以上所披露者外,於截至二零一六年三月 三十一日止年度,本公司概無持有其他重大 投資、進行重大收購或出售附屬公司及聯屬 公司,亦無其他重大投資計劃或資本資產。

擔保

年內,本集團於香港之附屬公司已向兩名馬來西亞獨立第三方承諾就該等獨立第三方與本集團一間聯營公司所訂立之設備租賃協議提供企業擔保。該等協議之期限介乎48個月至59個月,而向聯營公司收取之平均月租約為每名獨立第三方23,000令吉(相等於每名獨立第三方約46,000港元)。

除上文所披露者外,於二零一六年三月三十 一日,我們並無擁有任何重大擔保。

Employees and Remuneration Policies

As of 31 March 2016, the Group had 27 full-time employees. The Group offers a competitive remuneration package commensurate with industry practice and provides benefits to its employees, including bonuses, medical coverage and provident fund contributions.

The Group has arranged for its Hong Kong employees to join the Mandatory Provident Fund (MPF) Scheme. Under the MPF Scheme, each of the Group companies (the employer) and its employees make monthly contributions to the scheme at 5% of the employees' earnings as defined under the Mandatory Provident Fund Legislation. The contributions from each of the employers and employees are subject to a cap of HK\$1,500 per month and thereafter contributions are voluntary.

The Company has adopted a share option scheme as an incentive to its Directors and eligible employees of the Group, details of which are set out in the paragraph headed "Share Option Scheme" below.

Share Option Scheme

A share option scheme (the "Share Option Scheme") adopted by the Company was approved by its shareholder on 5 March 2015. Unless otherwise cancelled or amended, the Share Option Scheme will remain in force for 10 years from 5 March 2015. Under the Share Option Scheme, the Directors may in its absolute discretion offer to grant to any qualified participant an option to subscribe for the number of shares at an exercise price determined by the Board, being at least the highest of (i) the closing price of shares of the Company as stated in the Stock Exchange's daily quotation sheets on the date of the offer of grant; (ii) the average of the closing prices of the shares of the Company as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the date of the offer of grant; and (iii) the nominal value of the shares of the Company. The offer of a grant of options may be accepted within 20 business days from the date of the offer. HK\$1.00 is payable by any qualified participant to our Company on acceptance of the option offer as consideration for the grant. Qualified participants include any Director or employee (whether full time or part time) of our Company and its subsidiaries and associated companies (as defined under the Companies Ordinance, Cap. 622 of the laws of Hong Kong).

Foreign Currency Exposure

Our Group's revenue and expenses are mainly in Hong Kong dollar which is the functional currency of all entities making up the Group. Our Group is mainly exposed to the foreign currency risk of Renminbi, US dollar, Malaysian Ringgit and Indonesian Rupiah. As Hong Kong dollar is pegged to US dollar, we do not expect any significant movement in the US dollar/Hong Kong dollar exchange rate. For the sensitivity analysis of the Group's results for the year in regards to a 5% appreciation in Hong Kong dollar against the relevant foreign currencies, details are set out in note 35 to the consolidated financial statements in this Annual Report. The Group currently does not have hedging policy against foreign exchange risk. The management will consider hedging significant currency exposure in future should the need arises.

Gearing Ratio

As at 31 March 2016, the gearing ratio of the Group was 19.3% (31 March 2015: 0.5%), which is calculated on the basis of the amount of total debts divided by the total equity. Such increase was due to the new bank borrowings that were drawn down during the year.

Dividend

The Board did not recommend the payment of any dividend for the year ended 31 March 2016.

The Company is not aware of any arrangement under which a shareholder has waived or agreed to waive any dividends.

The Company has adopted revised Terms of Reference of the Audit Committee on 3 February 2016 in compliance with and to address the new provisions in the Corporate Governance Code dealing with risk management and internal control systems and effective for the accounting period beginning on 1 January 2016.

The Board is of the view that, throughout the year ended 31 March 2016, the Company has complied, to the extent applicable and permissible, with the code provisions set out in the Corporate Governance Code, except for the deviation from code provision A.2.1 as explained under the paragraph "Chairman and Chief Executive Officer" below.

Compliance with the Required Standard of Dealings and Securities Dealing Code

The Company has adopted its own code of conduct for dealing in securities of the Company by the Directors and the relevant employees of the Group who are likely to be in possession of unpublished inside information of the Company (the "Securities Dealing Code"). Mr. WONG has been leading our Group as the Chief Executive Officer of the Company and one of our subsidiaries since 2009, thus, the Board believes that it is in the best interest of the Group to continue to have Mr. Mansfield WONG stav as the Chief Executive Officer and leader of the Board for effective management of our Group. The balance of power and authority is ensured by the operation of the senior management and the Board, which is comprised of experienced and high-calibre individuals. The Board currently comprises three Independent Non-executive Directors and has a fairly strong independence element in its composition. Therefore, the Board considers that the deviation from code provision A.2.1 is appropriate in the circumstances. The Board will review the management structure regularly and consider separating the roles of chairman and chief executive, if and when appropriate.

Throughout the year ended 31 March 2016 and up to the date of this Annual Report, the Board at all times complied with Rules 5.05(1) and (2), and 5.05A of the GEM Listing Rules relating to the appointment of at least three independent non-executive directors, representing at least one-third of the Board, with at least one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received the written confirmation from each of the Independent Non-executive Directors in respect of their independence pursuant to Rule 5.09 of the GEM Listing Rules. The Company is of the view that all Independent Non-executive Directors are independent in accordance with the independence guidelines as set out in the GEM Listing Rules.

Terms of Appointment and Re-Election of Directors

Each of the Executive Directors has entered into a service agreement with the Company for a fixed term commencement from 24 March 2015 (the "Listing Date") until and including the date of the third annual general meeting following the Listing Date and will continue thereafter until terminated by at least three months' written notice or payment in lieu to the other party. Each of the Non-executive Director and Independent Non-executive Directors has entered into an appointment letter with the Company with a term of three years commencing from the Listing Date.

According to the Company's article of association (the "Articles of Association"), at least one-third of the Directors for the time being shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years.

Any director appointed to fill a casual vacancy shall hold office until the first general meeting of shareholders and be subject to re-election at such general meeting, and any director appointed as an addition to the Board will be subject to re-election by shareholders at the first annual general meeting after initial appointment.

Continuous Professional Development of Directors

Every Director keeps abreast of responsibilities as a Director of the Company and of the conduct, business activities and development of the Company.

Every newly appointed director would receive formal, comprehensive and tailored induction on the first occasion of his appointment to ensure appropriate understanding of the business and operations of the Group and full awareness of director's responsibilities and obligations under the GEM Listing Rules and relevant statutory requirements.

Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. All Directors are encouraged to attend relevant training courses at the Company's expenses.

The Company generally gives written notice and draft agenda of regular Board meetings to each Director at least 14 days prior to the meetings. Agendas for each meeting are prepared by the Company Secretary in consultation with the Directors, and based on a forward calendar that helps ensure that all relevant matters for the year ahead are considered by the Board in a timely manner. All Directors are encouraged to contribute to the agenda setting process. Agendas and accompanying papers are sent to all Directors at least 3 days before each Board meeting or committee meeting for their review and to keep the Directors apprised of the latest developments and financial position of the Company so as to enable them to make informed decisions.

In addition to board papers, information relevant to the Company's financial position and latest developments is made available to Directors to keep them up to date. Structured monthly updates on the Company's performance, position and prospects are provided to Directors. The Directors also have access to the Company Secretary and senior management where necessary.

The Company Secretary is responsible to keep minutes of all Board meetings and committees meetings. Draft minutes are normally circulated to all Directors for comments within a reasonable time after each meeting and the final versions are open for Directors' inspection.

In the event that there is a potential conflict of interest arising out of any transaction to be entered into between the Group and a Director or their respective associates, the interested Director(s) shall abstain from voting at the relevant Board meetings of the Company in respect of such transactions and shall not be counted as a quorum of such Board meetings.

The primary duties of the Audit Committee are mainly to make recommendation to the Board on the appointment, re-appointment and removal of external auditor; review the financial statements and material advice in respect of financial reporting; and oversee financial reporting system, and risk management and internal control systems of our Company.

As at the date of this Annual Report, the Audit Committee comprises three Independent Non-executive Directors, namely Mr. CHUNG Koon Yan (Chairman of the Audit Committee), Mr. CHEUNG Yick Hung Jackie and Dr. WONG Chi Ying Anthony, with Mr. CHUNG possessing the appropriate professional qualifications and accounting and related financial management expertise.

The Audit Committee shall meet at least two times per year, or more frequently as circumstances require. The Audit Committee held four meetings during the year ended 31 March 2016. Individual attendance records of each Audit Committee member are set out in the table on page 32 of this Annual Report.

(a) The purpose of the Share Option Scheme

The Share Option Scheme seeks to provide an incentive for the Qualified Participants (as hereinafter defined) to work with commitment towards enhancing the value of our Company and the shares for the benefit of the shareholders, and to maintain or attract business relationships with the Qualified Participants whose contributions are or may be beneficial to the growth of our Group.

An offer of the grant of an option shall be made to the Qualified Participants by letter in such form as the Board may from time to time determine, requiring the Qualified Participants to undertake to hold the option on the terms on which it is to be granted and to be bound by the provisions of the Share Option Scheme (including any operational rules). The offer shall remain open for acceptance for a period of twenty business days from the date on which it is made. Subject to the terms of the offer letter, there shall be no general performance target to or minimum holding period for the vesting or exercise of options. An option shall be deemed to have been accepted and to have taken effect when the duplicate letter comprising acceptance of the option duly signed by the option-holder together with a remittance in favour of our Company of HK\$1.00 by way of consideration for the grant of the option shall have been received by our Company on or before the last day for acceptance as set out in the offer letter. The remittance is not in any circumstances refundable. Once accepted, the option is granted as from the date on which it was offered to the relevant Qualified Participant.

(d) Subscription Price

The subscription price ("Subscription Price") shall be a price determined by the Board but in any event shall be at least the highest of: (i) the closing price of the shares as stated in the Stock Exchange's daily quotations sheets on the date on which the option is offered to a Qualified Participant ("Offer Date"); (ii) the average of the closing prices of the shares as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the Offer Date; and (iii) the nominal value of the shares.

(b) 可參與人士

The maximum number of shares in respect of which options may be granted under the Share Option Scheme and any other share option schemes of our Company shall not in aggregate exceed the number of shares that shall represent 10% of the total number of shares in issue as at 24 March 2015 (i.e. the date of listing of the shares of the Company on GEM, "Listing Date"), i.e. 50,000,000 shares. For the purpose of calculating the scheme mandate ("Scheme Mandate"), options which have been lapsed in accordance with the terms of the relevant scheme shall not be counted.

(f) Maximum entitlement of shares of each Qualified Participant

Unless approved by the shareholders of the Company in general meeting in the manner prescribed in the GEM Listing Rules, the Board shall not grant options to any option-holder if the acceptance of those options would result in the total number of shares issued and to be issued to that Qualified Participant on exercise of his options (including both exercised and outstanding options) during any 12-month period exceeding 1% of the total shares then in issue.

(g) Timing for exercise of options

The period during which an option may be exercised in accordance with the terms of the Share Option Scheme ("**Option Period**") shall be a period of time to be notified by the Board to each option-holder, which the Board may in its absolute discretion determine, save that such period shall not be more than ten years commencing on the Offer Date.

(h) Life of the Share Option Scheme

The Share Option Scheme shall be valid and effective for a period of ten years commencing from the date on which the Share Option Scheme is deemed to take effect in accordance with its terms, after which period no further options will be granted but the provisions of the Share Option Scheme shall remain in full force and effect in all other respects. In particular, all options granted before the end of such period shall continue to be valid and exercisable after the end of such period in accordance with the terms of the Share Option Scheme.

1. General information, reorganisation and basis of presentation

Synergy Group Holdings International Limited (the "Company") was incorporated as an exempted company with limited liability in the Cayman Islands on 14 December 2011. The address of the Company's registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is Room 404B, 4/F, Block B, Seaview Estate, Nos. 4-6 Watson Road, North Point, Hong Kong.

The principal activity of the Company is investment holding. Details of the principal activities of the Company's subsidiaries are set out in note 31 to the consolidated financial statements. The Company and its subsidiaries are collectively referred to as the "Group" hereafter.

In connection with the listing of the shares of the Company on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), the Company underwent a reorganisation (the "Reorganisation") and the Company has become the holding company of its subsidiaries now comprising the Group since 5 March 2015. The shares of the Company were listed on GEM on 24 March 2015.

Details of the Reorganisation are set out in the section headed "History and Corporate Development" to the prospectus of the Company dated 13 March 2015.

Upon completion of the Reorganisation but before placing, the equity interest held by the Company's shareholders mirrored their respective percentage of equity interest in Synergy Group Worldwide Limited ("Synergy Worldwide") before the Reorganisation, where Synergy Worldwide was the then holding company of the Group. The Group is regarded as a continuation of Synergy Worldwide resulting from the Reorganisation as there is no change in the economic substance of the Group. Accordingly, the consolidated financial statements were prepared using the merger accounting and as if the current group structure had always been in existence. Accordingly, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows of the Group for the year ended 31 March 2015 include the results, changes in equity and cash flows of the companies now comprising the Group from the earliest date presented or since their respective dates of incorporation, whichever was shorter, as if the current group structure had been in existence throughout those years. The consolidated statement of financial position of the Group as of 31 March 2015 has been prepared to present the assets and liabilities of the companies now comprising the Group as if the current group structure had been in existence at that date. No adjustment is made to reflect fair values, or to recognise any new assets or liabilities as a result of the Reorganisation.

The consolidated financial statements for the year ended 31 March 2016 were approved and authorised for issue by the board of directors on 31 May 2016.

Amendments to HKAS 1 - Disclosure Initiative

The amendments are designed to encourage entities to use judgement in the application of HKAS 1 when considering the layout and content of their financial statements.

HKFRS 9 (2014) - Financial Instruments

HKFRS 9 introduces new requirements for the classification and measurement of financial assets. Debt instruments that are held within a business model whose objective is to hold assets in order to collect contractual cash flows (the business model test) and that have contractual terms that give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding (the contractual cash flow characteristics test) are generally measured at amortised cost. Debt instruments that meet the contractual cash flow characteristics test are measured at fair value through other comprehensive income ("FVTOCI") if the objective of the entity's business model is both to hold and collect the contractual cash flows and to sell the financial assets. Entities may make an irrevocable election at initial recognition to measure equity instruments that are not held for trading at FVTOCI. All other debt and equity instruments are measured at fair value through profit and loss ("FVTPL").

HKFRS 9 includes a new expected loss impairment model for all financial assets not measured at FVTPL replacing the incurred loss model in HKAS 39 and new general hedge accounting requirements to allow entities to better reflect their risk management activities in financial statements.

香港會計準則第1號(修訂本)-披露計劃

修訂本之設計乃為鼓勵實體於考慮彼等的財務報表的版面設計及內容時使用應用香港會計準則第1號時的判斷。

香港財務報告準則第9號(二零一四年版)-金融工具

香港財務報告準則第9號就金融資產的分 類和計量引進新要求。如果持有債務工 具的商業模式的目的為持有資產以收取 合約現金流(商業模式測試),及如果債 務工具載有合約條款而其產生僅僅是對 本金和尚未償還本金的利息的支付的現 金流(合約現金流特徵測試),則有關債 務工具一般按攤銷成本計量。就通過合 約現金流特徵測試的債務工具而言,倘 若實體商業模式的目的為持有及收取合 約現金流和出售金融資產,則該債務工 具透過其他全面收入按公平值(「透過其 他全面收入按公平值」) 計量。實體於初 始確認時可以作出不可撤銷的選擇,將 並非持作買賣的權益工具透過其他全面 收入按公平值計量。所有其他債務及權 益工具按公平值計入損益(「按公平值計 入損益」)計量。

HKFRS 9 (2014) - Financial Instruments - Continued

HKFRS 9 carries forward the recognition, classification and measurement requirements for financial liabilities from HKAS 39, except for financial liabilities designated at FVTPL, where the amount of change in fair value attributable to change in credit risk of the liability is recognised in other comprehensive income unless that would create or enlarge an accounting mismatch. In addition, HKFRS 9 retains the requirements in HKAS 39 for derecognition of financial assets and financial liabilities.

HKFRS 15 - Revenue from Contracts with Customers

The new standard establishes a single revenue recognition framework. The core principle of the framework is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services. HKFRS 15 supersedes existing revenue recognition guidance including HKAS 18 "Revenue", HKAS 11 "Construction Contracts" and related interpretations.

香港財務報告準則第9號(二零一四年版)-金融工具-續

香港財務報告準則第9號貫徹香港會計準則第39號有關金融負債確認、分類及計量規定,惟按公平值計入損益的金融負債除外,當中負債信貸風險變動導致的公平值變動金額於其他全面收入確認,除非這將產生或擴大會計錯配。此外,香港財務報告準則第9號保留香港會計準則第39號有關取消確認金融資產及金融負債的規定。

香港財務報告準則第15號 - 客戶合同收入

該新準則制定單一的收入確認框架。框架的核心原則為實體確認收入時應體現按反映實體預期有權就交換所承諾商品及服務得到的金額轉移所承諾商品或服務予客戶。香港財務報告準則第15號取代現有的收入確認指引,包括香港會計準則第18號「收入」、香港會計準則第11號「建造合同」及有關詮釋。

HKFRS 15 – Revenue from Contracts with Customers – Continued

HKFRS 15 includes specific guidance on particular revenue related topics that may change the current approach taken under HKFRS. The standard also significantly enhances the qualitative and quantitative disclosures related to revenue.

The Group is in the process of making an assessment of the potential impact of the above new/revised HKFRSs apart from HKFRS 16 and the directors so far concluded that the application of these new/revised HKFRSs will have no material impact on the Group's financial statements.

HKFRS 16 - Leases

HKFRS 16 supersedes HKAS 17 "Leases", HK(IFRIC) — Int 4 "Determining whether an Arrangement contain a Lease", HK(SIC) — Int 15 "Operating Lease — Incentives" and HK(SIC) — Int 27 "Evaluating the Substance of Transactions Involving the Legal Form of a Lease".

HKFRS 16 eliminates the classification by a lessee of leases as either operating or finance. Instead all leases are treated in a similar way to finance leases in accordance with HKAS 17 "Leases". Under HKFRS 16, leases are recorded on the statement of financial position by recognising a liability for the present value of its obligation to make future lease payments with an asset (comprised of the amount of lease liability plus certain other amounts) either being disclosed separately in the statement of financial position (within right-of-use assets) or together with property, plant and equipment. The most significant effect of the new requirements will be an increase in recognised lease assets and financial liabilities.

香港財務報告準則第15號 - 客戶合同收入 - 續

香港財務報告準則第15號載有關於個別收入相關課題的具體指引,其可能會變更目前根據香港財務報告準則所採用的方法。該準則亦大幅增加有關收入的定性及定量披露。

本集團正在評估除香港財務報告準則第 16號外上述新訂/經修訂香港財務報告 準則的潛在影響,而董事迄今的結論為 應用該等新訂/經修訂香港財務報告準 則將不會對本集團的財務報表造成重大 影響。

香港財務報告準則第16號 - 租賃

香港財務報告準則第16號已取代香港會計準則第17號「租賃」、香港(國際財務報告詮釋委員會)- 詮釋第4號「釐定安排是否包括租賃」、香港(常設詮釋委員會)- 詮釋第15號「經營租賃-優惠」及香港(常設詮釋委員會)- 詮釋第27號「評估牽涉租賃的法律形式的交易的內容」。

香港財務報告準則第16號消除按經營或融資租賃之承租人的分類。反之所有租賃均以根據香港會計準則第17號「租賃与與融資租賃類似的方式處理。根據香港財務報告準則第16號,租賃乃透過按其以於財務狀況表獨立披露(計入資產使用權)或與物業、廠房及設備共同披露的資產(包括租賃負債款項加若干其他金額)支付未來租賃款項的義務之現值確認債項而記錄於財務狀況表。新訂規則的最大影響為已確認租賃資產及金融負債增加。

HKFRS 16 - Leases - Continued

There are some exemptions. HKFRS 16 contains options which do not require a lessee to recognise assets and liabilities for (a) short term leases (i.e. lease of 12 months or less, including the effect of any extension options) and (b) leases of low value assets (for example, a lease of a personal computer).

HKFRS 16 substantially carries forward the lessor's accounting requirements in HKAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently. In classifying a sublease, an intermediate lessor shall classify the sublease as a finance lease or an operating lease as follows: (a) if the head lease is a short-term lease that the entity, as a lessee, the sublease shall be reclassified as an operating lease; (b) otherwise, the sublease shall be classified by reference to the right-of-use asset arising from the head lease, rather than by reference to the underlying asset.

HKFRS 16 clarifies that a lessee separates lease components and service components of a contract, and applies the lease accounting requirements only to the lease components.

The Group is in the process of making an assessment of the potential impact of application of HKFRS 16, the directors consider that it is not practicable to provide a reasonable estimate of the effect of the adoption of HKFRS 16 until the Group performs a detailed review.

香港財務報告準則第16號 - 和賃 - 續

當中亦有若干豁免。香港財務報告準則 第16號包括並無規定承租人就(a)短期租 賃(即12個月或以下的租賃,包括任何 延長權利的影響)及(b)低價值資產租賃 (例如租賃個人電腦)確認資產及負債之 權利。

香港財務報告準則第16號大幅度保留香港會計準則第17號內之出租人的會計等 或。因此,出租人繼續將其租賃分類為經營租賃或融資租賃,並將該兩種租赁分別入賬。就分租的分類而言,中介資租人應按下列條件將分租分類為融資租賃。(a)倘主租賃乃短期租赁而該實體為承租人,則分租應參照租賃產生的使用權資產而分類,而非參照相關資產。

香港財務報告準則第16號澄清承租人區 分合約的租賃元素及服務元素,並僅就 租賃元素應用租賃會計要求。

本集團現正就應用香港財務報告準則第 16號的潛在影響進行評估,董事認為, 在本集團進行詳細檢視前提供採用香港 財務報告準則第16號影響的合理估計並 不可行。

(c) Amended GEM Listing Rules (as belowmentioned) relating to the presentation and disclosures in financial statements

The amended Rules Governing the Listing of Securities on the GEM of the Stock Exchange (the "Amended GEM Listing Rules") in relation to the presentation and disclosures in financial statements, including the amendments with reference to the Hong Kong Companies Ordinance, Cap. 622, apply to the Company in this financial year.

The directors consider that there is no impact on the Group's financial position or performance, however the Amended GEM Listing Rules impacts on the presentation and disclosures in the consolidated financial statements. For example, the statement of financial position of the Company is now presented in the notes to the financial statements rather than as a primary statement and related notes to the statement of financial position of the Company are generally no longer presented.

3. Basis of preparation

(a) Basis of compliance

The consolidated financial statements have been prepared in accordance with all applicable HKFRSs, HKASs and Interpretations (hereinafter collectively referred to as "HKFRS") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the GEM of the Stock Exchange.

(b) Basis of measurement

The financial statements have been prepared under the historical cost basis.

(c) Functional and presentation currency

The financial statements are presented in Hong Kong Dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

與財務報表的呈列及披露有關之經修訂 聯交所創業板證券上市規則(「經修訂創 業板上市規則」)(包括參考香港《公司條 例》(第622章)作出的修訂)於本財政年 度應用於本公司。

董事認為本集團的財務狀況或表現概不 會受影響。然而,經修訂創業板上市規 則對綜合財務報表的呈列及披露有所影 響。舉例而言,本公司財務狀況表現時 於財務報表附註呈列,而非以主要報表 呈列,故本公司財務狀況表的相關附註 一般不再呈列。

(a) 合規基準

綜合財務報表乃根據所有適用香港財務報告準則、香港會計準則及詮釋(下文統稱「香港財務報告準則」)及香港《公司條例》的披露規定編制。此外,財務報表包括聯交所創業板證券上市規則規定之適當披露資料。

(b) 計量基準

財務報表乃根據歷史成本基準編制。

(c) 功能及呈列貨幣

財務報表以港元(「港元」)呈列,且除另有所指外,所有數值已概約至最接近千 位。

4. Summary of significant accounting policies

(a) Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the dates of acquisition or up to the dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

(b) Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee, (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment losses, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

綜合財務報表包括本公司及其附屬公司 的財務報表。集團公司之間的公司內部 交易及結餘連同未實現溢利乃於編制綜 合財務報表時全數對銷。未實現虧損亦 會予以對銷,除非該項交易提供已轉移 資產減值的證據,而在該情況下,則會 在損益中確認虧損。

年內收購或出售之附屬公司之業績由收 購日或截至出售日止(按適用者)計入綜 合全面收益表內。附屬公司的財務報表 於必要時會作出調整,以使其會計政策 與本集團其他成員公司所採用的會計政 策貫徹一致。

(b) 附屬公司

附屬公司指本公司能對其行使控制權之被投資方。倘具備以下全部三項元素,則本公司即對被投資方擁有控制權:(i)對被投資方擁有權力、(ii)就被投資方可變回報承受風險或享有權利,及(iii)具有行使權力以影響該等可變回報之能力。倘有事實及情況顯示任何該等控制權元素可能有變,則將會重新評估控制權。

在本公司的財務狀況表中,於附屬公司 的投資乃按成本減去減值虧損(如有)後 列賬。附屬公司之業績乃由本公司按已 收及應收股息入賬。

(c) Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

(c) 聯營公司

聯營公司為一間本集團對其擁有重大影響力而並非屬附屬公司或共同安排的實體。重大影響力乃有權參與被投資方之 財務及經營政策決定之權力,但並非控 制或共同控制該等政策。

聯營公司乃採用權益法入賬,據此,聯營公司初步按成本確認,此後其賬面值 乃就本集團應佔於聯營公司資產淨值的 收購後變動予以調整,惟除非有責任彌 補該等虧損,否則超過本集團於聯營公司的權益的虧損不會被確認。

本集團與其聯營公司之間的交易所產生 的損益僅以不相關投資方於聯營公司的 權益為限予以確認。投資方應佔該等交 易所產生的聯營公司損益與聯營公司的 賬面值對銷。倘未變現虧損證明所轉移 資產出現減值,則即時於損益中確認。

任何就聯營公司所支付高於已收購本集團應佔可識別資產、負債及或然負債的公平值之溢價會撥充資本,並計入聯營公司的賬面值內。倘客觀證據證明聯營公司投資經已減值,則投資的賬面值以與其他非金融資產相同的方式進行減值測試。

(d) Joint arrangements

The group is a party to a joint arrangement where there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the group and at least one other party. Joint control is assessed under the same principles as control over subsidiaries.

The group classifies its interests in joint arrangements as either:

- Joint ventures: where the group has rights to only the net assets of the joint arrangement; or
- Joint operations: where the group has both the rights to assets and obligations for the liabilities of the joint arrangement.

In assessing the classification of interests in joint arrangements, the Group considers:

- The structure of the joint arrangement;
- The legal form of joint arrangements structured through a separate vehicle;
- The contractual terms of the joint arrangement agreement; and
- Any other facts and circumstances (including any other contractual arrangements).

The Group accounts for its interests in joint ventures in the same manner as investments in associates (i.e. using the equity method – see note 4(c)).

Any premium paid for an investment in a joint venture above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the investment in joint venture. Where there is objective evidence that the investment in a joint venture has been impaired the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

The Group accounts for its interests in joint operations by recognising its share of assets, liabilities, revenues and expenses in accordance with its contractually conferred rights and obligations.

(d) 共同安排

當有合約安排賦予集團及至少一名其他 訂約方對安排之相關活動共同控制權 時,則集團為共同安排之訂約方。共同 控制權乃根據與附屬公司控制權之相同 原則予以評估。

集團將其於共同安排之權益分類為:

- 合營公司:倘集團僅對共同安排的 資產淨值擁有權利;或
- 合營業務:倘集團具有共同安排的 資產之權利及負債之義務。

於評估於共同安排之權益之分類時,本 集團會考慮:

- 共同安排之架構;
- 透過獨立公司組織之共同安排之法 定形式;
- 共同安排協議之合約條款;及
- 任何其他事實及情況(包括任何其 他合約安排)。

本集團乃按與於聯營公司投資之相同方式(即使用權益法 - 請參閱附註4(c))對 其於合營公司的權益入賬。

任何就於合營公司的投資所支付高於本 集團應佔所收購之可識別資產、負債及 或然負債之公平值之溢價會予以資本 化,並計入於合營公司投資之賬面值。 倘有客觀證據顯示於合營公司之投資經 已減值,則按與其他非金融資產相同之 方式對投資之賬面值進行減值測試。

本集團透過確認其根據合約所賦予之權 力及義務而應佔之資產、負債、收入及 開支對其於合營業務之權益入賬。

(e) Property, plant and equipment

Property, plant and equipment, other than construction in progress ("CIP") are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to the working condition and location for its intended use. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to the profit or loss during the period in which they are incurred.

Depreciation on property, plant and equipment other than CIP is provided over their estimated useful lives, using the straight line method. The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted, if appropriate, at each reporting date. The estimated useful lives are as follows:

Leasehold improvements 3 years or over the lease terms, whichever is shorter

Furniture, fixtures and office 2 years equipment

Lighting systems 5 years

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss upon disposal.

(e) 物業、廠房及設備

物業、廠房及設備(在建工程(「在建工程」)除外)按成本減累計折舊及累計減值虧損列賬。資產成本包括其購買價及將資產達致運作狀況及地點作擬定用途之任何直接應佔成本。其後成本僅在與該項目相關之未來經濟利益很有可能歸於本集團並能可靠計量項目成本之情況下,方會計入資產的賬面值或確認為獨立資產(按適合者)。所有其他成本(如修理及維護)於其產生之期間於損益中扣除。

CIP, which is stated at cost less impairment losses, representing lighting systems pending installation as well as cost incurred during the periods of installation and testing. No depreciation is provided for in respect of construction in progress until it is completed and ready for its intended use.

(f) Revenue recognition

Revenue from sales of goods is recognised on transfer of risks and rewards of ownership, which is at the time of delivery and the title is passed to customer.

Leasing service income consists of:

- operating lease rental income and is recognised on a time proportion basis over the period of lease term; or
- finance lease income and is recognised over the period of lease using the effective interest method.

Consultancy and management service income is recognised when services are rendered.

The Group as lessor

Amounts due from lessees under finance leases are recorded as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

The Group as lessee

Assets held under finance leases are initially recognised as assets at their fair value or, if lower, the present value of the minimum lease payments. The corresponding lease commitment is shown as a liability. Lease payments are analysed between capital and interest. The interest element is charged to profit or loss over the period of the lease and is calculated so that it represents a constant proportion of the lease liability. The capital element reduces the balance owed to the lessor.

The total rentals payable under the operating leases are recognised in profit or loss on a straight-line basis over the lease term. Lease incentives received are recognised as an integrated part of the total rental expense, over the term of the lease.

Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted-average basis. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

(j) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand, form an integral part of the Group's cash management.

(k) Financial Instruments

(i) Financial assets

The Group classifies its financial assets at initial recognition, depending on the purpose for which the asset was acquired. Regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. A regular way purchase or sale is a purchase or sale of a financial asset under a contract whose terms require delivery of the asset within the time frame established generally by regulation or convention in the marketplace concerned.

Loans and receivables

These assets are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers (trade debtors), and also incorporate other types of contractual monetary asset. Subsequent to initial recognition, they are carried at amortised cost using the effective interest method, less any identified impairment losses.

(v) Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Any transaction costs associated with the issuing of shares are deducted from share premium, net of any related income tax benefit, to the extent that they are incremental costs directly attributable to the equity transaction.

(vi) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Group and not designated as at fair value through profit or loss is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount determined in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets"; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised in accordance with HKAS 18 "Revenue".

(I) Income taxes

Income taxes for the year comprise current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Deferred tax is measured at the tax rates expected to apply in the period when the liability is settled or the asset is realised based on tax rates that have been enacted or substantively enacted at the end of reporting period.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, associates and jointly controlled entities, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period except for differences arising on the retranslation of non-monetary items in respect of which gains and losses are recognised in other comprehensive income, in which case, the exchange differences are also recognised in other comprehensive income.

Short term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related service.

Defined contribution

Contributions to defined contribution retirement plans are recognised as an expense in profit or loss when the services are rendered by the employees.

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(q) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, which will probably result in an outflow of economic benefits that can be reasonably estimated.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, the existence of which will only be confirmed by the occurrence or non-occurrence of one or more future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(r) Related parties

- (1) A person or a close member of that person's family is related to the Group if that person:
 - (i) has control or joint control over the Group;

In addition to information disclosed elsewhere in these financial statements, other key sources estimation uncertainty that have a significant risk of resulting a material adjustment to the carrying amounts of assets and liabilities within next financial period are as follows:

(i) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of competitor actions in response to severe industry cycles. Inventory value is reduced when the decision to markdown below cost is made. Management reassesses the estimations at the reporting date. The carrying amount of inventories is disclosed in note 19.

(ii) Impairment of trade and other receivables

The Group's management assesses the collectibility of trade and other receivables on a regular basis to determine if any provision for impairment is necessary. This estimate is based on, where appropriate, the evaluation of collectibility and ageing analysis of the receivables and on the management's judgment. A considerable amount of judgment is required in assessing the ultimate realisation of these outstandings, including the current creditworthiness and the past collection history of each debtor. If the financial conditions of the Group's debtors were to deteriorate, resulting in an impairment of their ability to make payments, provision for impairment may be required. Management reassesses the provision for impairment at the reporting date. The carrying amounts of trade and other receivables are disclosed in notes 20 and 21, respectively.

When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise. The carrying amount of finance lease receivables is disclosed in note 18.

(iv) Depreciation

The Group depreciates property, plant and equipment using straight-line method over the estimated useful lives, starting from the date on which the assets are placed into use. The estimated useful lives reflect the directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the Group's property, plant and equipment. The carrying amount of property, plant and equipment is disclosed in note 14.

(v) Impairment of non-financial assets

The Group assesses at the end of each reporting date whether there is an indication that an asset may be impaired. If any such indication exists, the Group makes an estimate of the recoverable amount of the asset. This requires an estimation of the value-in-use of the cash-generating unit to which the asset is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating unit and also to choose a suitable discount rate in order to calculate the present value of those cash flows. A change in the estimated future cash flows and/or the discount rate applied will result in an adjustment to the estimated impairment provision previously made.

(vi) Warranty provision

The Group generally offers 2-3 years warranty for the lighting products during which free warranty service for the repair and maintenance of parts and components under normal usage is provided to the customers. The warranty provision provided during the year, depending on the product type, was based on the past experience of the failure rate of the products in the warranty service period. The carrying amount of warranty provision is disclosed in note 25.

(vii) Income tax

Determining income tax provisions requires the Group to make judgment on the tax treatment of certain transactions. The Group carefully evaluates tax implications of transactions in accordance with prevailing tax regulations and makes tax provisions accordingly. In addition, deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences can be utilised. This requires significant judgment on the tax treatments of certain transactions and also assessment on the probability that adequate future taxable profits will be available for the deferred tax assets to be recovered. The carrying amount of provision for taxation and deferred tax liabilities are amounted to approximately HK\$7,635,000 (2015: HK\$7,346,000) and HK\$118,000 (2015: HK\$404,000) as at 31 March 2016.

The board of directors meets periodically to analyse and formulate measures to manage and monitor the Group's exposure to market risk including principally changes in interest rates and currency exchange rates, credit risk and liquidity risk. Generally, the Group employs a conservative strategy regarding its risk management. As the Group's exposure to market risks is kept at a minimum level, the Group has not used any derivatives or other instruments for hedging purposes. The Group does not hold or issue derivative financial instruments for trading purposes. The board of the directors of the Company reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's interest rate risk arises primarily from long-term borrowings. Borrowings issued at variable rates and at fixed rates expose the Group to cash flow interest rate risk and fair value interest risk respectively. The interest rate of the Group's borrowings is disclosed in note 26. The Group adopts centralised treasury policies in cash and financial management and focuses on reducing the Group's overall interest expenses.

The following table details the interest rate profile of the Group's borrowings at the end of the reporting period.

At 31 March 2016, it is estimated that a general increase/decrease of 50 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's results for the year by approximately HK\$126,000 (2015: Nil). No impact would be on other components of consolidated equity in response to the general increase/decrease in interest rates.

The sensitivity analysis above has been determined assuming that the change in interest rates had occurred at the end of reporting period and had been applied to the exposure to interest rate risk for the borrowings in existence at that date. The 50 basis point increase or decrease represents management's assessment of a reasonably possible change in interest rates over the period until the next annual reporting date. The analysis is performed on the same basis for year ended 31 March 2015.

Foreign currency risk

The Group's revenue and expenses are mainly in HK\$ which is the functional currency of all entities making up the Group. As at 31 March 2016, the Group's assets and liabilities denominated in other currencies other than HK\$ are disclosed in notes 18, 20, 23, 24 and 25. The Group currently does not have a foreign currency hedging policy. However, management monitors foreign currency exposure and will consider hedging significant foreign currency exposure should the need arise.

The Group is mainly exposed to the foreign currency risk of RMB, US\$, RM and IDR. As HK\$ is pegged to US\$, the Group does not expect any significant movement in the US\$/HK\$ exchange rate and this is excluded from the sensitivity analysis below as in the opinion of directors, such sensitivity analysis does not give additional value in view of insignificant movement in the US\$/HK\$ exchange rates as at the reporting dates.

Before accepting any new lease contract, the Group assesses the credit quality of each potential lease and might demand certain customers to place deposits with the Group at the time the lease arrangement is entered into. In addition, the Group monitors and controls the trade receivables regularly to mitigate the risk of significant exposure from bad debts, reviews the recoverable amount of each individual trade receivables at each reporting date to ensure that adequate impairment losses are made for irrecoverable amounts. Normally, the Group does not obtain collateral from customers.

The Group's revenue derived from the Australia Customer, amounted to approximately HK\$35,999,000 (2015: HK\$22,305,000) which accounted for approximately 28% (2015: 20%) of the Group's total revenue for the year. The corresponding trade receivables contributed approximately HK\$37,872,000 (2015: HK\$15,333,000) which accounted for approximately 45% (2015: 26%) of the Group's trade receivables as at 31 March 2016.

The Group closely monitors the credit risk on individual customers based on their credit worthiness. In addition, the Group has assessments which involve the customer's past payments history and current ability to pay and take into account information specific to customers as well as pertaining to the economic environment in which the customers operate.

Credit risk in cash and cash equivalents is mitigated as cash is deposited in bank of high credit rating.

Fair values

The fair values of the Group's financial assets and liabilities are not materially different from their carrying amounts because of the immediate or short term maturity.


